E-Tech Galaxy Terms and Conditions Revised Aug 26, 2021

By applying to purchase from E-Tech Galaxy and/or by making payment, you acknowledge agreement to the following terms and conditions:

1. To receive rates listed, a buyer must purchase at least 10 items quantity per invoice minimum.
2. Once an order has been placed, SO generated, the order is locked in and cannot be cancelled.
3. Payments must be received within 3 business days of a SO being generated. Finance charges may be accrued after 3 business days of no payment.
4. Only form of payment is via bank wire and the wire must come from an account owned by the approved buyer with their name attached to it; any funds received from an unauthorized buyer or account will NOT be accepted or returned. Make sure to Include invoice # on bank wire notes.
5. Once wire is received into our bank, we typically ship out the order within 2 business days.
6. Unless otherwise agreed upon between both parties, E-Tech Galaxy will choose the shipping carrier. We often use FedEx Ground for smaller orders and reputable freight companies for larger orders.
7. No returns. All sales are final unless Dead on Arrival or wrong model # sent.
8. If there are any cancels or returns after SO generated or at any part of the process thereafter there will be a minimum 15% restocking fee and could be more depending on condition of product, time lapsed.
9. The buyer is responsible for all return shipping costs.
10. All items purchased from us must be sold in compliance with U.S. laws: no shipping to hostile countries or on the no-ship-to list.
11. We are not responsible for typographical errors in specs: buyer must confirm specs to the part number.
12. Prices listed do not include freight. the default shipping rates within the continental 48 United States is \$3/laptop. Some larger item could include additional freight. Rates outside of the continental U.S. are higher. Please contact your sales representative to confirm shipping rates before placing an order.
13. Any damage on freight shipment must be notated on the Bill of lading at time of delivery, otherwise we will not be responsible for the damage.
14. New products usually come with limited manufacturer warranties, but these are not guaranteed by E-Tech Galaxy – the buyer must contact the manufacturer to confirm. Buyers can also contact their sales representative with any questions regarding warranty before placing an order.
